- Kenya National Commission for UNESCO
  (KNATCOM) in collaboration with the Ministry of
  Education initiated the development of a
  holistic M&E framework for the education
  sector.
- In 2020, a Technical Working Group (TWG) team was formed comprising all the state departments in the Ministry of Education, SAGAs, TSC and relevant Government agencies
- The M&E framework encompasses creating a robust real time monitoring, reporting and evaluation of the education sector including Competency Based Curriculum, SDG4 and CESA 16-25.




## Why Monitoring and Evaluation Framework?




- To create synergy among the MDAs in monitoring and data management
- ➤ To facilitate harmonised monitoring and reporting for Education Agenda 2030 and the Continental strategy for Africa 2016-2025
- > To facilitate timely reporting at the national ,regional and global levels
- > Identify problems early and proposes solutions
- Monitor access to project services and outcomes by the target population

#### Project Overview

- Project name Together for a New Africa
- Collaborative initiative with International Association New Humanity (a UNESCO affiliated NGO)
- Covers DRC, Rwanda, Burundi, Tanzania, Uganda, Kenya and South Sudan.
- Interdisciplinary, intercultural training for global citizenship, civic engagement driven by common values of common good, peace and fraternity.
- Training carried out by volunteer professors and youth experts from Sophia University Institute, Loppiano Italy and Country specific universities
- Trainers also double as guides for the in- country youth groups for project planning and implementation
- Objective: to empower young people in Africa to be able to face the challenges of our continent as global citizens and as current and future leaders and to strengthen the nexus of civil society and civic engagement for common good at community and national level.
- Project cycle: 3-year project comprising of annual 10-day summer schools in Nairobi where youth from the various countries learn and showcase projects and initiatives undertaken through out the year.
- 100 120 youth trained in each summer school;

# Outcomes in 2020: Local activities at National Level



- Tanzania One beneficiary, elected to represent youth in the ruling party.
- DRC- Awareness raising on COVID- 19 prevention through radio broadcasts
- Kenya participation in community work and organizing of an advocacy program via Facebook to discuss Identity and Leadership
- Uganda Video Campaign on COVID- 19 Awareness and tress planting/growing 500 tree planted
- Burundi assistance to 123 needy persons in collaboration with Humanite Nouvelle and COVIC – 19 Awareness
- South Sudan Video Messaging on COVID 19
